DIRECTIONS FOR USE

Add 1/2 oz. of dishwashing liquid to 1 to 2 gallons of water in wash basins or sink. Wash dishes as usual and wipe or drain dry. For exceptionally greasy dishes, a small addition of more liquid may be desired.

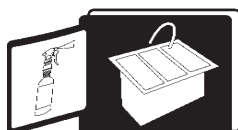
